Once again! The past practice of the WCRCC has been, until the past couple of years, to provide the names, addresses, telephone numbers and precincts of each WCRCC member. The only concern pressed until the administrations of Kumar and Khan has been with the release of email addresses. Finding those who desired not to have their email address released was moved and passed several times at the EC meetings over the past several of years and the WCRP officers have failed to accomplish the task; especially the Secretary as the Secretary was instructed to send the email requesting email opt out. So why not get off of the stool and accomplish the directive and in the meantime provide the 38 years plus past practice and provide the names, addresses, phone numbers and precincts of the WCRCC to each member via electronic file vs. the stated position of only via paper which doesn't make any time or funding sense! This nonsense has been carried on for too long of time and it is interfering with the operation and communications within our WCRCC and between and in support of Republican candidates!

The constant delay of achieving positioning of chairs for committees, delaying notifications of activities, etc. apparently for individual and /or personal reasons has to end so that our party may begin to function. We should have received the WCRCC list for those elected at the Convention of Saturday last by now! As the list was prepared and utilized on the convention screens in digital format it should have been nearly 100% correct and any corrections should have been minimal at best thus its digital file should have been available certainly by today, Friday, April 8, 2016. Not having information out as to how WCRCC members may nominate for the WCRCC offices to be elected on the 26th of this month, the nominations for the five (5) at-large WCRCC members to the EC, the nomination to the state central committee and the dates, times and location(s) of town hall meetings for those desiring to fill the four WCRCC officer positions continues to cripple the WCRCC committee and its functioning as a viable asset to and for Republican candidates in this election year!

It appears as though the officers of the WCRCC who have resigned (The Treasurer and the first Vice Chairman tendered their resignations for April 2nd), the Chairman was removed by vote of the WCRCC in meeting, a quorum of the WCRCC in attendance, on March 24th and the Secretary stating her resignation as of April 26th, the officers not recognizing their individual resignations and the removal of the Chairman by the WCRCC are attempting to continue their denial of the wishes of the WCRCC in that the WCRCC accepted their resignations by vote. They also appear to be containing their destruction of the WCRCC and the WCRP through they neglect at establishing an active and resourceful County Party. It may well be concluded that the aforementioned officers are attempting to exclude individuals from being active within the party due to personal dislikes and the effort to ensure that only those individuals who have the same total ideas as theirs will be permitted to participate within party activities.
